4a (Code:) (Expenses \$ 313,570 including grants of \$ 1,171) (Revenue \$) Survivor Care - Anew offers programs to address the complex traumas created by sex trafficking. Survivors are provided a safe and stable environment where they can work on restoring good health and habits, discover and develop growing passions, and learn needed skills for a fulfilling life in the future. As survivors move through these phases they are offered a variety of free resources and opportunities such as Trauma-Centered Therapy, Medical and Dental Care, Court Advocacy and Legal Support, and Life Skill Development and Wellness Coaching. There are 3 separate Survivor Care Programs that walk the long-term journey of restoration of survivors. This includes our 18-24 month Residential Program, 18-24 month Non-Residential Program, and Community Participation (for those checking out their options and considering Anew for long-term care and for the woman who has completed long-term care and benefits from staying connected to community and serving as a leader).

4b (Code:) (Expenses \$ 107,403 including grants of \$) (Revenue \$) Survivor Outreach - Anew's goal is to reach out to women where they are at and empower them along a journey of exiting "the life" and working toward long-term restoration. We connect with these women through four main outreach programs: Street Outreach, Strip Club Outreach, Jail Outreach and Court Advocacy.

4c (Code:) (Expenses \$ 48,304 including grants of \$) (Revenue \$) Awareness & Prevention - Anew is dedicated to educating individuals in our community about domestic sex trafficking (DST). We offer, at no cost, presentations to any business or agency throughout North/Central Florida. 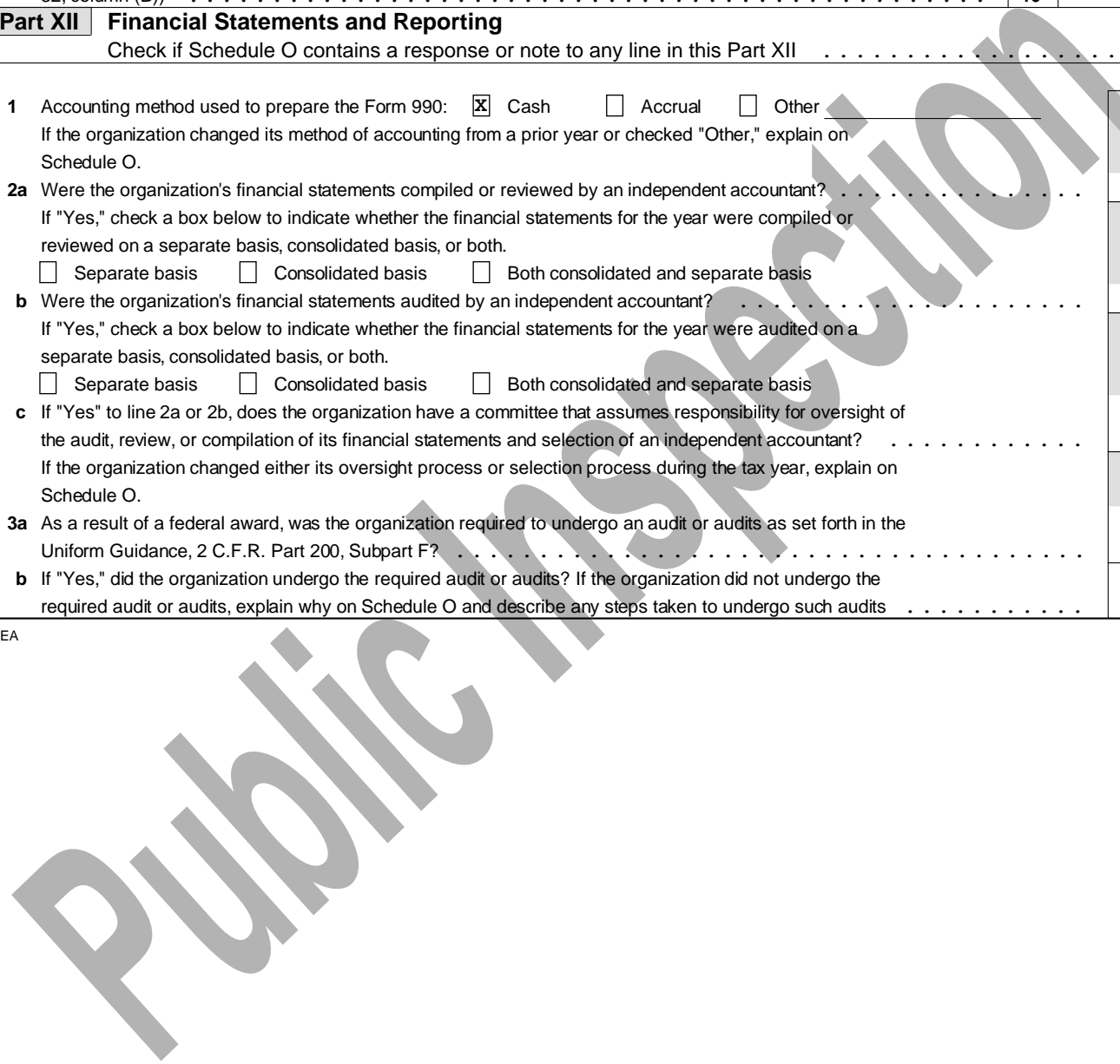
